Public Parties: are held during open swim hours and includes a two hour reserved party area with four tables and 18 chairs. Maximum of 18 guests, (anyone attending the party whether they get in the pool or not). You can add additional guests for \$2/person. Patrons may stay and swim after the party has ended but the party area **must** be cleared out on time. Additional fees may be added if party area remains used after scheduled time.

Private Parties: are held before or after open swim hours and includes the entire facility excluding the concession stand. Concession stand can be available upon request. Maximum of 75 guests. You may add additional guests for \$15/hour (25 guests), \$30/hour (50 guests), or \$45/hour (75 guests).
