2. I waive all claims against the Released Parties for any injuries, damages, losses, or claims whether known and unknown, which arise during or as a result from my participation in the Activity, regardless of whether caused or not caused in whole or in part by the negligence or other fault of any of the Released Parties. I release and forever discharge the Released Parties from all such claims.
3. I agree to indemnify and hold harmless the Released Parties from all losses, liabilities, damages, costs, or expenses (including, but not limited to attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I (or anyone claiming by, under, or through me) may bring against any of the Released Parties to recover my losses, liabilities, costs, damages, or expenses which arise during or as a result from my participation in the Activity, regardless of whether or not caused in whole or in part by the negligence or other fault of any of the Released Parties.
