Hi Jerry,

Per our discussion on changing the burned out lights at the ball fields, We can do the job on a time and materials basis and save you some money. That way you only pay for our time actually spent on the project and not on a bid price. The bulb cost is: apx. \$35 per bulb and the labor is \$89.00/hr for (1) man and the high reach truck. Example.... If we were to change 18 lamps and it took 2 full days to get that done (which it shouldn't) the total cost would be \$1855.48 plus tax.

Also attached is the rendering for a pylon sign for the water park. It shows a digital in place but this can be removed and added in at a later date if not approved for this time around. If this design is something that interests you, I can meet you and we can go over pricing and options. I'm available most all of this week if you want to get together.
