**Bolivar Aqua Zone Season Pass Holder Agreement**

Contains a release and waiver of liability

In consideration for the City of Bolivar agreeing to allow me to use the facilities and services of the Bolivar Aqua Zone, I agree to the following:

I am fully aware of the risks inherent in the physical activities and programs at the aquatics facility, and I agree to only engage in and permit my family members to only engage in activities and programs at the swimming pool which are appropriate for me and my family.

I will indemnify, defend, and hold harmless the City of Bolivar and its agents, officers, employees, and volunteers for any claims against them as a result of any use of City facilities and programs by me and my family.

The laws of the State of Missouri shall govern this Agreement. Jurisdiction and venue of any legal action regarding this Agreement shall be exclusively in the Circuit Court of Polk County, Missouri.

If any provision of this Agreement is held to be unenforceable or void, the remaining provisions shall remain in force and effect. This Agreement and Application contain the entire agreement between me and the City of Bolivar and is contractual and not a mere recital. The City reserves the right to make any modifications, amendments, or waivers upon written notice.

**\* The City reserves the right to suspend or terminate Season Passes for noncompliance of rules and regulations established by the City from time to time and/or for improper aquatic facility etiquette.**

**BOLIVAR AQUA ZONE RULES AND REGULATIONS**

- 1) All patrons must pay or show pass at front desk upon arrival to the pool.
- 2) Season passes can only be use during City of Bolivar public swim time. Passes do not include special events.
- 3) All patrons must comply with signage in the aquatic facility and locker rooms.
- 4) Children under the age of 10 must be accompanied by an adult at all times while in the aquatic facility.
- 5) **Any child 9 and under must have an adult swimmer with them in the water at all times** (only exception is a child that can pass the swim test, in this case the adult must still be in the aquatic facility)
- 6) No flotation devices may be brought into the aquatic facility except for coastguard approved lifejackets. Children wearing a lifejacket must have adult with them in the water.
- 7) Behavior and language in the Aquatics facility should be respectful of others. Verbal assault will not be tolerated.
- 8) Proper attire is required, this is a family friendly zone and swimming attire should represent that.
  - a. NO Jeans will be allowed in the water
  - b. NO provocative swim attire will be allowed
- 9) NO alcoholic beverages allowed.
- 10) Cake, decorations and any other party supplies are not allowed in the aquatic facility unless party area has been reserved and paid for.
- 11) No outside food or drinks may be brought into the aquatic facility, with the exception of those that have reserved and paid for party area.
