

Administrator Report:

City Administrator Tracy Slagle presented the administrators report. The City has submitted the CARES Act application to the County Commission for around \$106,000. in expenses incurred through May 31, 2020 due to COVID-19. We were informed that the State is waiving unemployment fees for entities, which will include the Shared work program the City has been doing for the last several weeks. The Storm Siren on the North Side of town has been replaced with proceeds from a grant. A separate CARES Act grant application for the Bolivar Airport has been submitted for \$30,000. The Show Me Court online system for the Courts has been going on this week, to be implemented July 1st, 2020. GIS will have updated maps soon. The Fire Department will have a 6:00 p.m. promotion ceremony June 24th, 2020. Alderman Sagaser made a motion to approve the Administrators report. Aldermen Keith seconded the motion, which was unanimously approved.

Mayoral Appointment: Introductions, Presentations, Resolutions, Proclamations,

Liberty Utilities (Missouri Water) LLC representative John Donaldson addressed the City. Liberty Utilities has made the Public Service Commission (PSC) aware that Liberty Utilities is planning on making a filing for sale of the water, sewer and wastewater systems. Typical timeframe puts the submission to PSC during 4th quarter 2020 and have an answer from PSC April 2021. Liberty Utilities really appreciates the opportunity to work together with this transition.
