Ballfield Expenses.

Public Works Director Jerry Hamby discussed the need for power to be extended to the north 3 ballfields at Fullerton Fields, for the scoreboards. Estimates for conduit is \$1,500. A cordless scoreboard controller has been ordered for \$1,931.40. Staff will be using a generator to try out the existing scoreboards with the remote controller. Aldermen Sagaser made a motion to spend \$1,931.40 for the scoreboard controller. Further discussion and Aldermen Sagaser amended the motion to spend up to \$5,000.00 for conduit and the scoreboard controller. Aldermen Keith seconded the motion, which was unanimously approved.

Administrator Report:

City Administrator Tracy Slagle gave an update on with Liberty Utilities. The Public Works have been working on installing drainage for the Base Ball Fields at Fullerton Park, and clearing out the wooded area around the fields for the walking trails, and building a couple of picnic benches. Recently, the crews have cleared out the stream by the youth park at the request of the Friends of Bolivar Parks. Its that time of year for Code Complaints season, residents can call 417-328-5824 for code issues. Public Wi-Fi is available at the Park & Rec Center, Fullerton Fields and the Splash Pad. Utilities and Admin are under staffed currently, so individuals from public works and golf have come over to help.

Police Chief Mark Webb will update the City on his Annual Report 2020. Summarizing -accidents are down this year, 191 crashes, 15,309 calls, 750 arrests. Animal Control had 447 calls, over 75 dogs were turned back to the owners. Drug take back in 2020 took in 240 lbs. Training Room was completed in 2020. Several major cases- murder, active drug cases, with proactive investigations are on-going. Shop with a Cop helped 173 kids for Christmas, the number was reduced by covid. The Police Department is working towards getting Calea Accreditation. Dwain Lockhart was recognized for 41 years of service. Chief Webb and the staff thanked the board for the approval of three vehicles, several crown vics will be retired.
