Liberty Utilities Update

City Administrator Tracy Slagle gave an update that plans are still in place for the sale of the water and wastewater system to be completed January 31st, 2022. Proposed dates of the January and February Utility bills mailing dates explained.

Confirm Sprayer Purchase

City Administrator Tracy Slagle explained due to the nature of used equipment a call was made to the alderman to approve the purchase. This motion is to ratify the approval process. Alderman Sagaser made a motion to approve the \$20,000 Sprayer with Professional Turf Products, L.P. Alderman Neal seconded the motion, which was unanimously approved.

Workshops will consist of looking at proceeds from the Liberty sale and American Rescue Fund allocations. Dates are set for Tuesday, Feb 15th and Wednesday, Feb 16th at 6:00 p.m. May Regular Session and September Work Session may need to be rescheduled at a future date, due to conference conflicts. City Administrator asked for a change order on the Fire Garage improvements. Now would be a good time to consider enclosing the outside stairwell on the Fire Department portion of the Public Safety Center. Cost estimates would be around \$9,000. Alderman Keith made a motion to complete the project to enclose this area. Alderman Ballard seconded the motion, which was unanimously approved. J.W. Hackworth, Regional Director of Business Development from Liberty gave a quick update on the upcoming sale still looking like January 31st, 2022. He answered any questions from the Board of Aldermen.

Gail Noggle, Executive Director of the Economic Development Alliance gave the annual presentation for the Alliance. The city/county partnership is going strong for the last 6 years. This past year Tracker Marine continued on its expansion and we are seeing signs of the travel center.
