Requirements

- **Roof**
 - Tear off, haul away, and disposal of current shingles and underlayment
 - Make any necessary decking repairs
 - Installation of synthetic underlayment
 - Installation of 30 yr. or better architectural shingles
- **Gutters**
 - Tear off, haul away, and disposal of current gutters and downspouts
 - Installation of new seamless gutter and appropriate downspouts

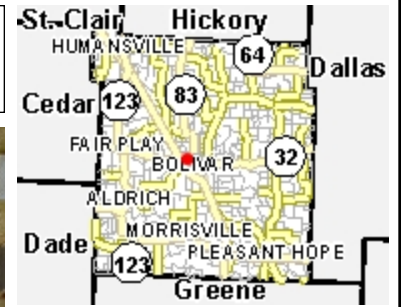
1. Detailed list of all labor and materials needed to accomplish the above requirements

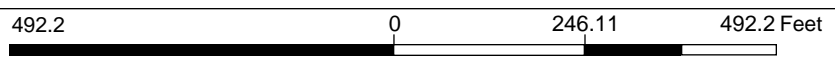

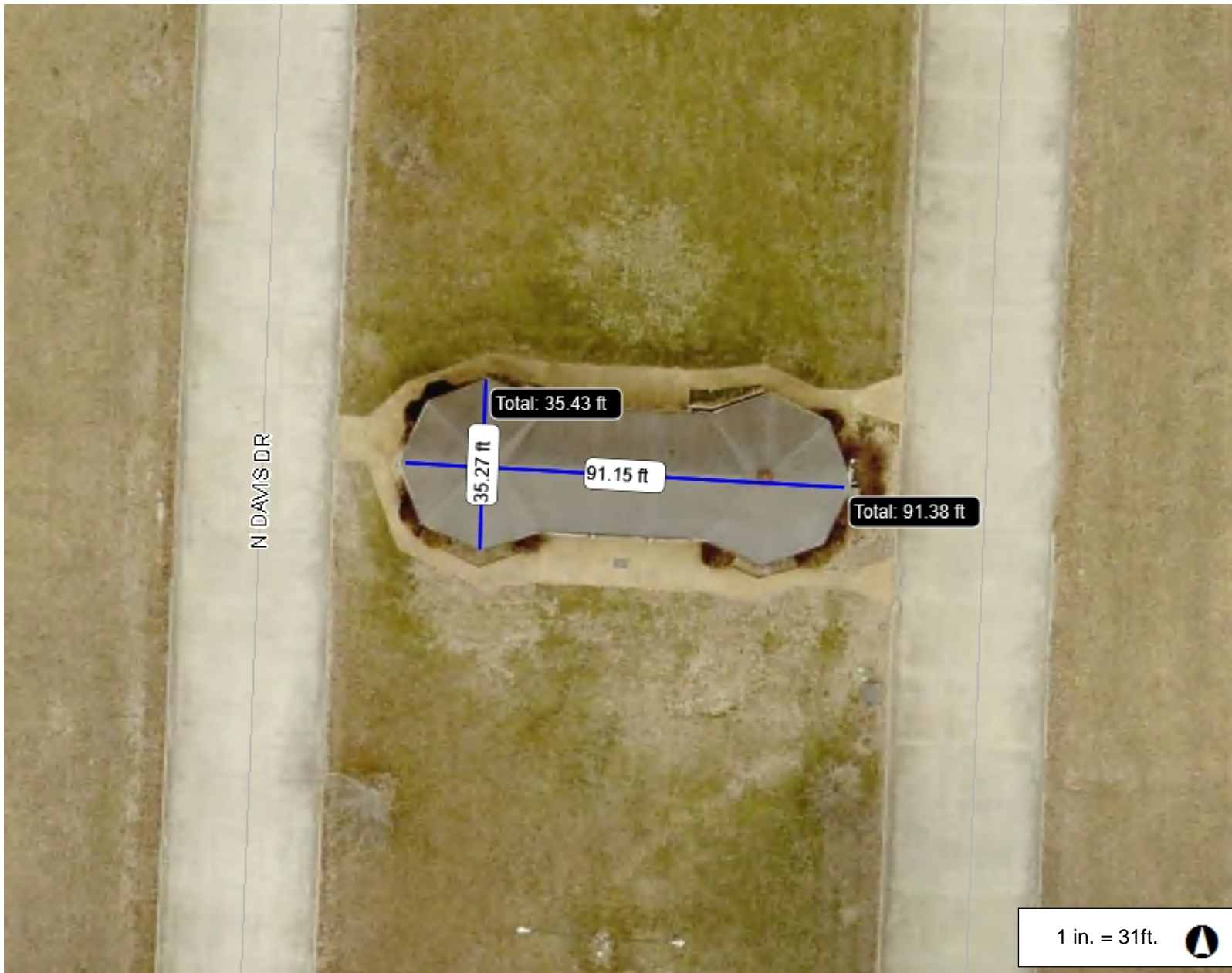
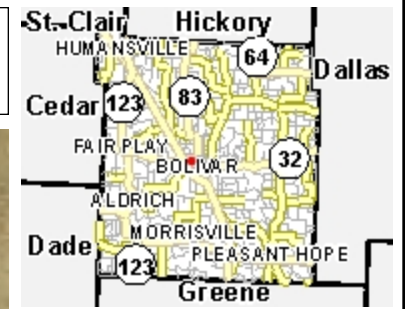

Polk County, MO



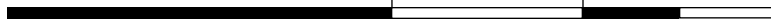
